INTRODUCTION

These rules and conditions govern membership and associated rights and obligations of all Members of Meadowbank Pony Club Inc and are designed for the safety of all Members and visitors, the welfare of horses and ponies, and to ensure that the Club enjoys the highest reputation with local residents.

MEMBERSHIP

Applications for Membership:

Any person who wishes to become a member of the Club must apply in writing on the official application form with all details correctly completed.

All applications must be signed by the applicant for Senior or Adult membership or a parent/guardian of a Junior member applicant and once approved immediate payment of the application fee which shall be non refundable.

The Committee reserves the right to reject or accept any application for membership as they see fit.

Membership Conditions:

By applying for membership of the Club, the applicant (including parents or guardians of applicants for junior membership) agrees to be bound by:

- A) these Rules and Conditions;
- B) decisions of the President or the Committee provided for in these Rules and Conditions; and
- C) the New Zealand Pony Clubs Association Rules and Regulations for Areas, Clubs and Branches.

In the event of any conflict between these Rules and Conditions and the NZPC Rules, the President shall determine which provision takes priority.

Junior Members

Junior Members are not entitled to exercise the power to vote at Club meetings, therefore it is required that the parent/guardian of a Junior Member becomes a financial Member which entitles them to voting rights and a place on the committee.

Suspended Membership (Leave of Absence):

Members who wish to withdraw from riding membership and grazing for a period of time may apply to the committee for Leave Of Absence. On their return they will be given priority on the waiting list for a grazing space, provided that their financial membership is maintained. This means that annual subscriptions must be paid. Members who are leaving the club for short periods can retain their grazing place by continuing to pay their full grazing/maintenance fees.

The grazing contract is a seasonal contract. Therefore horses which are taken out and grazed elsewhere for short periods during the winter season or the summer season must have their grazing fees paid in advance to Meadowbank Pony Club without interruption. If a horse is to leave mid-season and will not return for that season, then payment of grazing fees will cease and the particular grazing space will be relinquished for the remainder of the season.

Membership Fees:

Membership fees are as set out in Schedule 1. In addition to annual fees, an Entry Fee of \$300.00 is due when a member first joins. Fees payable in subsequent years include annual Club subscriptions and levies to Auckland District Pony Club, Auckland Area, and New Zealand Pony Club Association.

The Committee will review all fees from time to time and notify changes by the Club's website or otherwise as the Committee sees fit. Any change in fees shall be deemed to be incorporated in Schedule 1 with effect from the date stipulated by the Committee as the effective date for new fees.

Members agree to pay membership and other fees as set by the Committee from time to time in consideration of continued membership of the Club.

RALLIES

Attendance

Riding members must attend a minimum of seventy five percent of rallies per season for membership and grazing seniority to be retained. Attendance will be measured for compliance before Christmas and again at the conclusion of the season. If seventy five percent of rallies have not been attended, members will lose their seniority in grazing and their horses will be placed in grazing wherever the committee considers appropriate. If rally attendance is unacceptable to the committee, horses will not be considered for winter grazing.

It is assumed all junior members will be attending rally unless they advise the Head Coach and Rally Co-ordinator no later than 5pm Monday prior to rally. Non attendance that has not been notified to both Head Coach and Rally Co-ordinator will incur a \$10 non attendance fee. This is due to the fact that coaches need to be confirmed prior to rally. On occasion due to circumstances such as illness or injury of horse or rider on the day this fee may be waived at the discretion of the Rally Co-ordinator or Head Coach.

Riders must attend the whole rally and be ready to ride on time. If they are late, or leave the rally early, they will be marked present for only half the rally. Rallies and Horse Management lessons must be attended if certificate record cards are to be signed. Completed certificate record cards must be presented at examinations.

Competitors in pony club events and candidates in pony club certificate exams must have participated in at least five working rallies during the twelve months prior to the event or its closing date for entry. Three of these rallies must be mounted on the horse to be ridden in the competition or exam. The District Commissioner may give dispensation to good pony club members who have been unable to fulfil these requirements if they apply in writing to the District Commissioner. Similarly, a member must have ridden a horse at three rallies before competing for the trophies belonging to the Club. The President may give dispensation to a rider who has not been able to fulfil these requirements, provided they apply before the event.

Dress Code and Horse Care:

On rally days all riding members must be correctly dressed in Pony Club uniform of light coloured jodhpurs, Jodhpur boots, Meadowbank Pony Club polo shirt and approved helmet. Meadowbank Pony Club jackets may be worn for warmth. Junior riders must wear Jodhpur boots; senior riders may wear long boots or full-grain leather gaiters.

All saddlery and gear must be clean and serviceable and will be checked for safety and cleanliness before the ride. Horses and ponies must be groomed with their hooves showing proper care and attention.

Safety:

When a ride breaks up, either for a break or at the end of the rally, riders should move off at a safe pace.

Riders must at all times show respect to, and obey their instructors. In the event of an emergency all riders should immediately dismount and hold their horses or ponies.

Riding at Rallies:

On a rally day, the Show Jumping and Dressage Arenas, Telephones 1 and 2 paddocks are closed for riding 2 hours before and 1 hour after the rally.

If a horse needs working in before a rally, permission to do this will be granted at the discretion of the committee or head coach.

Rally Assistance:

Set up and clean-up for rallies is a weekly expectation of riding members and/or their parent/helper. This does not count as a Working Bee. All riding rallies, events, specialized days and any organized pony club activities must be carried out under the supervision of an instructor.

Supervision:

All members under the age of 18 (junior members) must have a supervisor aged 18+ present at rallies if they are riding. As well as supervision (note this is not the role of the coach) the supervisor will be expected to assist with tasks such as adjusting jumps, or in the case of arena work, ensuring the arenas are raked, and all droppings removed. Where a supervisor is not present, the parent/guardian must appoint someone 18+ to be that members supervisor, and advise the Head Coach and Rally Co-ordinator prior to rally commencing.

Dogs:

There are to be no dogs at rallies, events, training clinics .

WORKING BEES

Club Working Bees:

Members, and the parents of Junior members, must provide the Pony Club with a minimum of 9 hours working bee labour during each membership year plus such further hours set at the discretion of the President.

Failure to supply working bee labour on the date specified for the working bee will result in the member being charged a \$100 working bee levy. Attendance and hours at the working bee will be recorded by the working bee manager. There is no longer an option to do the working bee hours at another date and time. Failure to attend, provide labour on the working bee date or pay the \$100 non-attendance levy could result in a loss of seniority for grazing, or taken into consideration for grazing privileges.

Paddock Working Bees:

Paddock Working Bees may be organised by the Paddock Manager as she/he deems necessary, and each grazing member is required to participate. Paddock Working Bees are additional to Club Working Bees.

Non-grazing members are exempt from Paddock Working Bees.

Event Working Bees:

Help with preparing and running is an expectation of each and every club member and does not count as a working bee day. If you are riding in a club event, you or a substitute must help set up and/or clear down. The Committee reserves the right to deny a rider entry in an event if no help is given.

Every Member or a parent of a junior member must attend at least one Event Working Bee each year and perform an Event Day Job during at least one Event each year.

Non-grazing members must contribute to Event Working Bees.

EVENTS

Events Support:

Money made from events such as, ODE's, Open Days, Ribbon Days and closed Club trophy events enable us to function as a club, offering a high standard of instruction, providing necessary equipment and maintenance of the property.

Members are expected to regularly support Events by entering to compete and volunteering to help on the day of events.

All members must provide at least 1 member or family participant to help at Open Days. If a family cannot provide a helper, provision of a suitable pony club mount that can be used for pony riders is acceptable. If neither can be provided a \$100 non-attendance fee will apply. This fee reflects the importance of Open Days for MPC fundraising.

GRAZING

Applications for Grazing:

All grazers must be financial Members before an application for grazing will be accepted. Membership does not automatically entitle grazing rights.

Grazing contracts are renewed seasonally.

All applications for grazing must be on the appropriate form and must be submitted for consideration by the Committee by the due dates for applications as advised from time to time. *Forms can be obtained from the Membership Co-Ordinator or are available for download from the website.*

A Vet Certificate showing vaccination for strangles and tetanus is up to date must be attached to the Application Form and accepted by the Committee.

All Members requiring grazing, whether for summer or winter, must sign a Junior, Senior, Adult or GFU grazing contract and submit it with the application for grazing.

Winter Grazing:

Winter grazing is limited to around 24 horses and is not guaranteed to all grazing Members. Members are invited to apply for winter grazing in April each year and preference is given to longer standing members and those who have consistently contributed to the club throughout the season.

Grazing Fees:

Grazing Fees are as set out in Schedule 1 and shall be reviewed by the Committee from time to time but shall remain fixed for the term of each grazing contract.

Grazing fees shall be paid by automatic bank payment fortnightly in advance to:

Payment must be arranged before the member commences grazing.

Failure to pay grazing fees will result in removal of grazing privileges.

Every horse grazing on club grounds for a season, (i.e. the summer - October to May or winter - June to September); will continue to incur grazing fees for the whole season, even if the horse is taken out for periods. Every horse grazing on the grounds is subject to grazing fees, including horses on two weeks trial, horses in sick paddocks and horses in stables.

Grazing members are able to bring a second horse on trial for a maximum of two weeks, with the approval of the President. The horse does not need to be tube drenched, but should have been on a regular worming programme and should be healthy. The horse needs to be pasted upon arrival on club grounds.

Grazing fees will be incurred for the extra horse and it is the responsibility of the member concerned to arrange payment with the Treasurer.

Eligibility of Horses:

To be eligible for grazing on the Pony Club property the horse must be no less than 5 years of age. The horse must be broken in and rideable. A stand-down period of 6 months will apply to horses recently gelded. All horses are subject to approval by the head coach.

Upon acceptance horses must be pasted or drenched no more than 5 days prior to coming onto Club grazing. The Member must produce a Vet Certificate confirming this has been done and confirming details of current tetanus and strangles vaccinations. Stallions are not acceptable.

Grazing Rules:

Members grazing horses at the Club shall observe the following rules at all times during the term of grazing.

1. Horses must be checked daily by or on behalf of the member.
2. Neglect or ill treatment will not be tolerated at any time.
3. The Grazing Coordinator will arrange drenching or pasting with the product being supplied by the Pony Club. All grazing members must meet on the arranged day/time for worming of horses. Failure to do so will incur a \$50.00 fee per horse unless prior arrangements have been made.
4. Hard feed is not to be fed inside the paddock or where horses are grazing.
5. Hay will be supplied at the Grazing Coordinator's discretion.
6. In the case of veterinary emergencies, if the Member is not able to be contacted, their nominated vet will be called immediately and all fees incurred will be at the grazer's cost.
7. Should it be evident that a horse/pony show signs of ill health and a vet has not been called for directly by the Member, a member of the Committee is authorised at their discretion but under the advice of the Head Coach to call a vet to examine the horse. All costs associated with this examination will be the responsibility of the Member responsible for the horse.
8. All grazers must notify the Grazing Coordinator and Paddock Manager when a horse will be removed overnight or longer. Should you be away for any number of days, you must notify the Grazing Coordinator and Paddock Manager as to who is taking care of your horse on your behalf.
9. Grazers horses must be placed where the Grazing Coordinator deems fit. Grazers must be available to move their horses when requested or have made prior arrangement to have them moved by someone else.
10. No one may disregard the Grazing Coordinators instructions. Non rectified non-compliance may result in 14 days' notice of grazing termination.
11. On MPC competition days horses must be caught and moved **no less than 1 hour** before the start time from appropriate paddocks.
12. Any horse deemed to be extremely troublesome or a danger to other grazers, horses or people, or does not fit into communal grazing will be removed with instant termination of grazer's rights as per Grazing Coordinator's recommendation to the Committee. This includes exhibiting any vice deemed unsuitable for communal grazing.

13. There will be a maximum of one horse or pony per riding member allowed. Any variance to this may be at the discretion of the Committee.
14. Support, friendliness and respect for other members are expected at all times. Negative unfriendly and anti-social behaviour will not be tolerated. All members must abide by the NZPCA Code of Conduct and Harassment Policy.
15. It is the responsibility of EVERY grazing Member to ensure that:
 - The water troughs are kept clean and full.
 - Fences are inspected in every paddock on each visit and any damage repaired or reported.
 - All litter, particularly of a dangerous nature, (plastic bags, cans, bottles, wire, etc), is removed from paddocks to rubbish bins.
 - Damage to pastures is avoided by not riding on soft wet ground.
16. Grazing approval is for each member's specific horse at the time of application. If a member sells that horse and purchases another horse, that member MUST submit a new grazing application to the Grazing Coordinator for consideration. At time of new grazing application, all information the Grazing Coordinator deems necessary must be disclosed on the grazing application. This application may be presented to the committee if the Grazing Coordinator deems it necessary to do so. The new horse is not permitted to graze on MPC grounds until the new grazing application has been approved. A vaccination certificate for tetanus/strangles and pasting confirmation from a vet must accompany each application.
17. Every new horse to MPC's grazing system, even if under ownership of an existing member, will be subject to the 3 month trial period to monitor that horses suitability for communal grazing.
18. Grazing granted to any existing member for a *second* horse is conditional upon the understanding that this grazing may at any time be required to be relinquished in order to accommodate new members' grazing needs. As much notice will be given as possible, but not less than 10 days.

Paddocks and Grounds:

1. Currently, horses graze communally in allocated groups based on seniority as directed by the Grazing Coordinator. Paddock rotations are organised in consultation with the Grazing Coordinator.
2. Grazing members may be given tasks such as trough cleaning, weed control, poo kicking, feeding hay etc. These tasks must be completed to the Paddock Managers satisfaction.
3. It is the responsibility of all grazing members to report to their paddock manager any damage caused to fencing, troughs etc. including pens and club rooms. The Club reserves the right to require the member responsible for the horse to reimburse or compensate the Club for any damage caused.
4. Members are not allowed to change paddocks, put up pens/tape at their own volition except in cases of risk to safety or wellbeing of any person, horse or property.

Grazing System:

Members under 21 years are part of the **Priority-Grazing** system. The Grazing Manager determines the priority order of paddocks – generally those closest to the club rooms have the highest priority. Allocation is based on seniority of the riding members under 21 years of age (i.e. the length of time they have been financial members of the Club). All Members must attend at least seventy five percent of rallies or they will lose their seniority in grazing.

Contribution to and participation in club activities may become a factor in deciding whether or not a member is moved up to the next paddock group.

The Grazing Coordinator and Executive Committee will make transfers from group to group. Swapping between Members is not permitted.

Once a member turns 21 years they move out of the Priority-Grazing system into a senior paddock group if grazing is available.

Once a member turns 25 years they can no longer be an NZPCA junior/senior member and must apply for grazing as a Grazing Facility User (GFU) if they want to continue grazing at the club.

The club will not be accepting any more Adult Memberships.

Grazing preference will be given in the following order:

NZPCA Members under 21 years
NZPCA Members 21-24 years
NZPCA Adult Members 25 years plus
Grazing Facility Users (GFUs) 18 years plus

New members to the club begin grazing in the lowest priority paddocks. When a vacancy occurs in a paddock group the next most senior Member is asked to move up to that paddock group. If the Member declines to move for any reason, other than staying with another family member, that person loses one place on the seniority list permanently, and the person who moves up to the higher group gains that place on the seniority list permanently. Movement downward will be considered by the Committee only in exceptional circumstances

Each Paddock Group will have an adult in charge of the paddocks and this person will be responsible for the regular moving of the horses from one paddock to another. It is Club policy to graze one paddock for as long as possible while resting the other. Ideally both paddocks should not be grazed at the same time.

GENERAL RIDING RULES

Only financial Members and those given permission for casual use of facilities may ride on the grounds. Non-members (e.g. friends, relatives) of Members are not permitted to ride Members' horses on Club grounds without the permission of a Committee member and the riding Member must ensure that the non-member is familiar with Club rules, and has completed the required administrative documents. This is intended for friends and family to have a one-off ride. Permission must be sought also for members of other pony clubs to ride on Club grounds. Parents of Members may ride Members' horses, provided they are NZPCA financial members. Siblings of members may ride their siblings mount 5 times during a season for free. Once they have ridden more than 5 times, they need to join as a Facilities User.

Jumping:

On non-rally days riders should not practise jumping, enter bush trails, or use the cross-country course unless accompanied by one other person.

When using the Show Jumping Paddock, jump stands may not be changed if they are set up and flagged. If poles are removed they should be replaced. If poles are used as trotting poles, they must not be left on the ground after use.

Supervision:

It is the sole responsibility of the parent/caregiver to ensure Junior Members (NZPCA members aged under 18 years) have adequate supervision when riding on Pony Club grounds including rallies:

- Members aged under 16 years must be supervised by a responsible adult aged 18 years and over at all times.
- Members aged from 16 to 18 years who hold their C certificate or higher may ride together without adult supervision, however, there must be a responsible adult aged over 18 years if they are jumping.

- Members aged 18 years and over are permitted to ride by themselves, however MPC suggests that these riders use caution and carry a mobile phone at all times. Members aged 18 years and over are not permitted to jump alone.

Riding Helmets:

All riding members, including adults and instructors, must wear the correct NZPCA approved helmet and carry the correct tag as specified in the NZPCA rules. The helmet must be worn whether riding on Club grounds or on the road, fitting correctly and chin strap secured.

Body and Shoulder Protectors:

The Club strongly recommends to members that body and shoulder protectors be worn.

Halters, Straps and Stirrups:

Horses and ponies must not be ridden in halters or head-collars. If they do it will be considered at their own risk.

Suitable footwear must be worn while riding with stirrups – the footwear should have a heel and ideally would not have a heavily textured sole which could get caught in the stirrup iron. Safety stirrups may NOT be used.

Neck straps may be used for training.

Roads and Reserves:

ALWAYS USE THE PEDESTRIAN CROSSING OUTSIDE THE CLUBHOUSE when crossing St John's Road. Never attempt to cross the road except on the crossing.

Outside the Club grounds the Road Code and Auckland City Council By-Laws include the following requirements:

- Riders must ride on the left side of the road and as far to the left as is practicable.
- Riding is not permitted on the grass between houses and streets (the berm) or on footpaths or reserves.
- Riders must be in single file.
- Riders must always wear an approved helmet with the chinstrap secured.
- A horse being led must be kept on the left of the leader (i.e. the horse must be away from the traffic).
- If a horse is being ridden at night (an activity strongly discouraged by the Club) riders must wear clothing with reflector patches and carry a lit torch.
- **Any horse dropping deposited on roads or footpaths must be immediately removed. We suggest carrying a plastic bag with you at all times.**

Riding through Sunhill Garden car park is not permitted.

CLUB GROUNDS AND FACILITIES

Paddocks and Arenas:

Riding is permitted in all paddocks during the riding season, usually beginning in October and until the end of May.

During the winter (June to the end of September), the grounds may be open for walking and trotting only, at the discretion of the Grazing Coordinator/President.

While the grounds are closed only the Dressage Arenas may be used for riding. Horses must be led to the entrance to the arena, not ridden. Manure must be removed from the arena before you leave, using the stable rake provided, and arenas raked after use.

The Show Jumping Paddock may be closed at times because it is soft after rain and prone to damage. Poo is to be removed from the Show Jumping Paddock.

Paddock Security:

One key to the locks is supplied free to members. Extra keys may be copied or purchased from the club. The keys unlock all paddock gates and the door to the locker room. Always carry your paddock key. Shut and lock all gates behind you when you enter or leave a paddock-

Dogs

Dogs are to be kept on leads around the clubhouse, rally pens and in paddocks where horses are grazing at all times.

Water Troughs:

Report all leaks, broken hoses, ball cocks, etc IMMEDIATELY

Sick Pens:

There are small paddocks and covered pens beside the stables for the use of sick, lame or injured horses.

THE SICK PADDOCKS MAY NOT BE USED WITHOUT PRIOR APPROVAL OF THE SICK PENS CO-ORDINATOR

Members must follow the Sick Pen Rules on the board inside the area and refer to the sick pen rules document for use of the undercover sick pens.

Rally Pens:

The pens and wash-pad below the Clubhouse should be used for all grooming and tacking up. Horses must be securely tethered and not left unattended. The pens must be cleaned of manure immediately after the horse is removed from the pens to be ridden or to be returned to a paddock.

Members must follow the Rally Pens Rules on the board in the rally pens area.

Club-House:

Members must ensure the Club-House is kept in a clean and tidy condition and securely locked when not in use. Any damage must be reported to a Committee member immediately.

Holding Pens:

Members travelling to an event may use the Holding Pens beside the upper Dressage Arena. These pens are used on a first-in first-served basis and must be cleaned out immediately after use and the water supply must be checked on departure.

Stables:

Access to the Stables through Scarbro's yard should be respected at all times. Cars must travel very slowly. Horses should be led or ridden with extreme caution. All horse droppings must be immediately removed. The gate from the Club into the yard must be kept locked at all times to prevent access by vehicles not belonging to Club Members. Scarbro's own gateway and driveway should not be used by horses or vehicles.

Shoeing:

All shoeing must be done on the concrete pad outside the stables or in the rally pen area. Members must sweep up every nail clipping and all rasping's and place in rubbish when the farrier has finished with their horse. Discarded shoes may be put in locker room for re-cycling to scrap metal.

Clipping:

Clipping must be carried out by an experienced person. All hair must be cleaned up off the ground immediately.

Car, Truck and Float Parking:

The gravelled area by the Rally Pens and lawns around the clubhouse are for people and cars only. Horses must be kept away from here, unless passing through, floating, or on event days.

Floats and trucks must be kept only on the gravelled area. Parking should be agreed with the Committee. Trucks must not be parked on the lawn or in paddocks except on Event days and as directed by the Committee.

Members may park in front of the Pens and visitors should park on the grass around the clubrooms. Cars must not park in the area beside the wash-pads as floats need to have access to the hoses after being used.

GENERAL RULES

Private Instruction:

Members may receive private instruction on Club grounds, but no private instructor can expect to have full exclusive use of our facilities at the time of the lesson. It is the responsibility of the Member to ensure that the club rules are made known to the instructor.

Non-members cannot receive instruction on club grounds except on specially arranged courses approved by the Committee.

Buddy Scheme

MPC runs a family buddy scheme and it is expected all families and riding members participate in and support new members when they join the club.

Smoking:

Smoking is absolutely forbidden in the stables, locker room and barn areas. Members found smoking in these areas will be suspended from the Club for a period at the discretion of the Committee.

The Club supports a smoke free policy. There is to be no smoking around the Club-House, Pens or other riders.

Communication:

These Membership Rules and Conditions, including Schedules will be updated from time to time. The current edition at any time will be available on the Club's website at all times and Members are required to be familiar with them. Updates will be specifically notified on the website.

Our primary method of contacting Members individually or in groups will be via email. The Club will apply the following email policy:

Email Policy:

1. Group email is only for official use

2. Group email is not to be used for selling personal items or group chat
3. Email can be used judiciously to advise members of items that are of benefit to them, e.g.; horse dentist dates
4. Email lists are not to be distributed outside the club
5. Communication chain of command: Group emails to the entire membership on selected issues/complaints may not always be appropriate. In the first instance inform your Paddock Manager. The Paddock Manager in conjunction with the Grazing Coordinator and Committee will send the appropriate email communications to those specifically affected.
6. Any offensive or defamatory email among Members will be treated as a breach of the mutual respect the Club expects Members to observe and will be considered a disciplinary matter by the Committee.

Members must comply at all times with notices posted at the Club under the authority of the Committee.

Health & Safety

Meadowbank Pony Club takes the Health & Safety of its' members and members of the public very seriously. All members must adhere to the rules & at all times understand that safety is paramount. Members who disregard the rules will be subject to disciplinary action as determined by the committee. Meadowbank Pony Club has identified and notified Hazards and it is the responsibility of all members to advise the Health & Safety officer if they become aware of new or previously unidentified hazards.

An Accident Register is held on site (kept in the outside toilet) and all accidents requiring medical attention must be recorded and the H&S Officer notified. Any significant 'Near Miss' must also be recorded. (Please refer to the Health & Safety Manual for further information.)

Before any event can be held, a Risk Assessment must be documented identifying all potential hazards and how MPC will mitigate/manage these.
